2022: A Year of Celebration.

2022 marked an important milestone for our Health Center as we celebrated our 50th anniversary of helping people live healthier lives. It is hard to know if our Seven Founding Mothers ever envisioned the impact their dream would have on health equity throughout Central Massachusetts and beyond. We are forever grateful for their unwavering commitment in 1972 to establish a health center that would break the status quo and evolve into one of the largest community health centers in Massachusetts.

Of course, our incredible 50-year legacy would not have been possible without the support and dedication of hundreds of individuals throughout the years who believed that health care is a right in this country and not a privilege. Named after one of the most prolific spokesmen of our time on health equity, the Edward M. Kennedy Community Health Center stands as a beacon of hope and equality in our Commonwealth.

The following are highlights of our prestigious history:

Charles Estus, a business and community leader, along with Mick Huppert, who became the first executive director of Great Brook Valley Health Center, provided tremendous support to our Seven Founding Mothers in the early days of the Health Center.

2022: A Bright Future.

With 50 incredible years under its belt, one would think that Kennedy Community Health would be content with the status quo. But that is far from the truth. In reality, the Health Center is embarking on one of its largest expansions in its 50-year history with the opening of two new health centers: one in Milford and one in Worcester.

"When I started in my new role, I took very much to heart our mission, which is to help people live healthier lives," shares President and CEO, Stephen J. Kerrigan. "The only way we do that is if we're here and available to patients. However, I did get a very strong feeling early on as I toured our sites that we were at max capacity. Our Milford site, with just 5,000-squarefeet of space, was just bursting at the seams. My first or second week we turned a storage closet into a triage room because they just didn't have the space, and our

Tacoma Street site in Worcester was maxed out and unfortunately landlocked."

So, when a 30,000 square foot building at 605 Lincoln Street became available, the Health Center seized the opportunity to almost double its footprint in Worcester. With the opening of this facility, Kennedy Community Health will operate two large health center sites less than a half a mile apart, providing increased capacity for our patients and access to vital health care services, especially for our most vulnerable populations. The 605 Lincoln Street facility will house our Worcester-based dental, behavioral health and optometry practices, as well as a small pharmacy, urgent care and other ancillary services. Moving our behavioral health and dental practices to this new site is opening space at 19 Tacoma Street to increase access to primary care services.

The third floor of our 19 Tacoma Street facility was repurposed to host eight new medical exam rooms as part of our vision to increase access to primary care. A ribbon cutting with our new COO, Ruby Cherfils and one of our patients was held on September 12, 2022.

The need to expand in Milford became critical as well, due to the growing patient population With our current health center at 42 Cape Road serving over 6,000 patients each year and counting, and demand for community health services increasing exponentially in this region, our move to a new facility located directly across the street at 41 Cape Road will nearly triple our service capacity and allow us to address the demand for dental, optometry and pharmacy services that we were previously unable to offer. This larger site, which will open in March 2023, will also support an expansion of primary care, behavioral health, and other support services.

2022: A Year of Achievement

Kennedy Community Health had a lot to celebrate in 2022. Most prominent of course was the Health Center's 50th anniversary. A special time to reflect on our prestigious history, as we recognized our seven Founding Mothers for their determination to break the status quo and provide care to a population that had been overlooked by the area's healthcare delivery system.

However, amidst this time of jubilation, our great team kept up their pace in delivering the best care possible to our patients, keeping access to health care services open, all of which made 2022 an even more momentous year. Take a look!


